INDEPENDENT GARAGE GUIDE WHAT IS SERMI?

Security-Related Vehicle Repair & Maintenance Information

A new UK accreditation scheme giving independent garages legitimate access to vehicle security data — the same access as franchised dealers. access to vehicle security data — the same access as franchised dealers.

WHAT IS SERMI?

SERMI stands for Security-Related Vehicle Repair and Maintenance Information. It is a pan-European certification framework — developed jointly by vehicle manufacturers (via ACEA) and the independent repair sector — that gives accredited independent garages the legal right to access vehicle security data.

Prior to SERMI, accessing this level of security data was effectively the exclusive domain of franchised dealer networks. SERMI changes that — provided your garage meets the strict eligibility criteria.

UK LAUNCH & FIRST BRANDS

SERMI goes live in the UK on 1 April 2026, making the UK the first non-EU nations to adopt the scheme.

HOW IS SERMI DIFFERENT FROM SGW?

SGW (Security Gateway) is a hardware/software lock inside the vehicle — it controls which tools can communicate with the car's ECUs during a physical diagnostic session. SERMI is an accreditation and access scheme — it controls who is permitted to access manufacturers' secure online portals to obtain high-level security repair data, such as key programming algorithms, immobiliser configurations, and anti-theft system information. Both are important. SGW access keeps your in-bay diagnostics working. SERMI unlocks the security data behind those repairs.

REAL-WORLD EXAMPLE: WHY YOUR GARAGE NEEDS SERMI

Ford — Lost Key
 A Ford owner loses all their keys. Without SERMI access, the garage cannot obtain the PIN code or key programming data from Ford's secure portal. The customer is turned away or referred to a dealer.

Jaguar — Immobiliser
 A secondhand Jaguar arrives with an immobiliser fault after an ECU replacement. Solving it requires accessing JLR's security database — only available to SERMI-accredited operators.

WHAT WORK REQUIRES SERMI?

- Lost key / all keys lost — key programming
- Transponder and key fob coding
- Immobiliser reset or replacement
- Anti-theft system fault diagnosis
- Security-related ECU software updates
- Accessing encrypted wiring diagrams (security systems)
- Remote/online coding sessions requiring SERMI token

Note: Routine diagnostics (fault codes, live data, service resets) do not require SERMI accreditation.

WHO CANNOT APPLY?

Who Cannot Apply? Garages involved in DPF removal, emissions defeat devices, ECU tampering, odometer manipulation, or powerremapping beyond manufacturer limits will be refused. Any unspent criminal conviction is disqualifying.

INDEPENDENT GARAGE GUIDE SECURITY GATEWAY (SGW Access)

Why modern vehicles lock out diagnostic tools — and how authorised access keeps your workshop ahead.



WHAT IS A SECURITY GATEWAY?

From around 2018 onwards, many vehicle manufacturers began fitting a Security Gateway Module (SGW) — a digital firewall that sits between the OBD-II port and the vehicle's internal networks. Think of it like a locked door inside the car. Your diagnostic tool can knock on the door, but without the right authorisation code, many functions simply will not respond. This is not a fault — it is intentional, manufacturer-designed protection against cyber-attack and unauthorised vehicle manipulation.

Important: SGW access is not about bypassing manufacturer security — it is about being an authorised workshop. With the correct licence, your tool communicates exactly as a franchised dealer's equipment would.

REAL-WORLD IMPACT: WHAT GETS BLOCKED WITHOUT SGW ACCESS?

Fiat 500 — Service Reset

A customer brings in their Fiat 500 for a routine oil service. Without SGW authorisation, the diagnostic tool cannot communicate with the Body Control Module to reset the service light. Job incomplete.

VW Golf — Battery Registration

A new battery is fitted, but the engine management system is not told. Without SGW access, battery registration fails and the vehicle enters incorrect charging cycles, leading to early battery failure.

Alfa Romeo Giulia — Fault Code

Codes are readable, but without SGW access the tool cannot clear them or run actuator tests. The customer leaves thinking the job is done — but the warning light returns immediately.

Mercedes C-Class — DPF Regen

The DPF warning light is on. The technician attempts a forced regeneration — the command is sent but the gateway denies it without a valid SGW authorisation. The customer must visit a dealer.

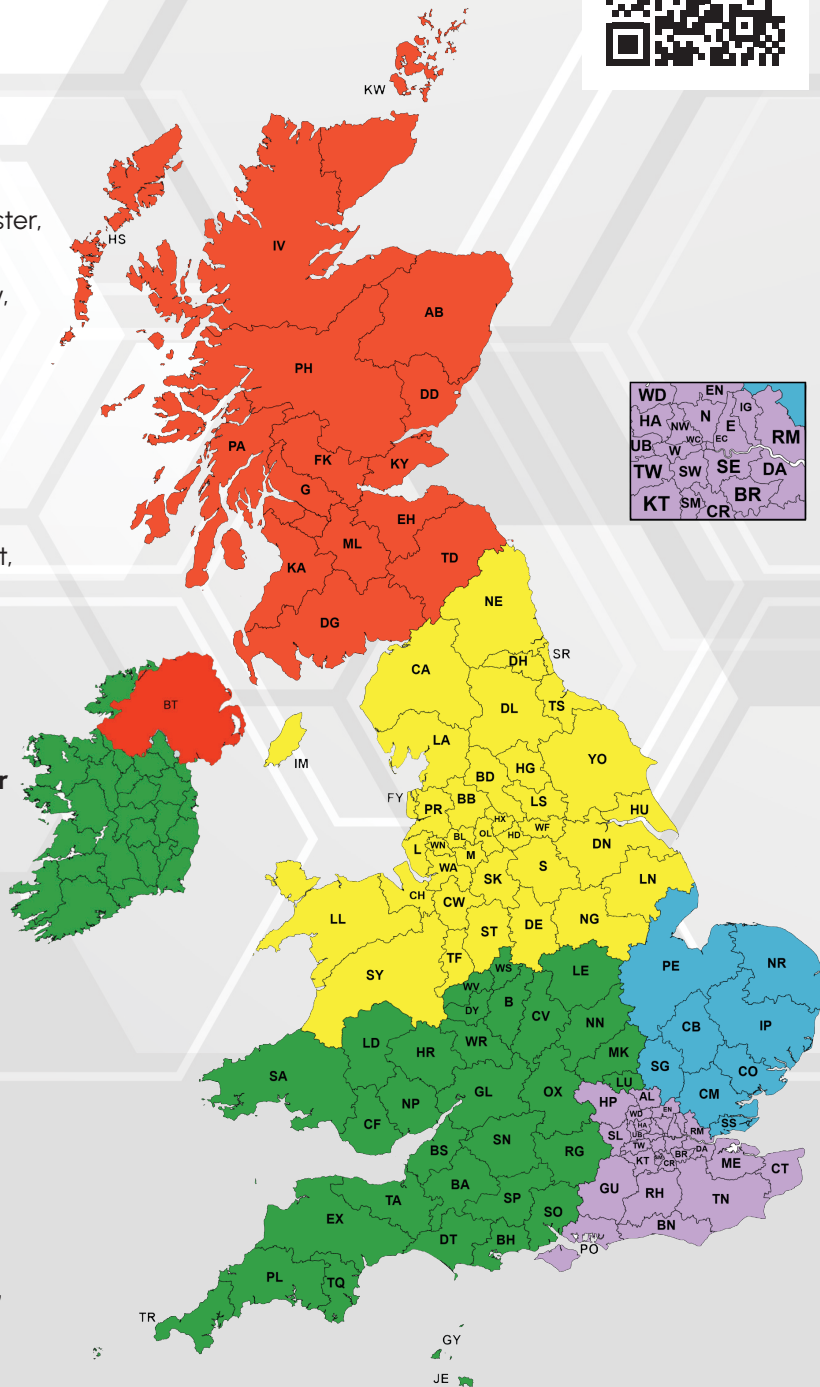
